During an exchange an Exchange Student may have the opportunity to participate in various sporting and recreational activities. These activities may carry some risk of injury. It is recommended that the Exchange Student and their parents or legal guardians discuss this matter and agree between them, the type of activities that the Exchange Student may participate in, and the basis of, such participation. This form is to evidence that this matter is acknowledged and that the Exchange Student has been given direction and guidelines by their Parent(s) or Legal Guardian(s)

We acknowledge that the above is not a definitive list of possible activities with potential injury risk. The guidelines provided to the Exchange Student allow them to participate in such activities except as recorded below.

Appendix A Risk Sports & Recreational Activities

Where the Exchange Student wishes to partake in any Risk sport or recreational activity:

It is suggested that the following be complied with in **ALL** cases:

1. The Exchange Student has written consent from their natural parents or legal guardians to undertake sports and recreational activities especially where there is a higher injury risk.
2. The Exchange Student has adequate medical insurance that is valid in the country, and for the full term, of their Rotary Exchange.

The Exchange Student has been advised by their Parents/Guardians and accepts that:

- Participation in Risk sports and recreational activities could result in injury, or may even be fatal.
- They should undertake the activity only with their enthusiastic participation and if they are satisfied that the activity is appropriately licensed and safe.
- They should not take part in any activity of this sort about which they feel uncomfortable or apprehensive.
- It is the Exchange Student's responsibility to check compliance of operators with the above requirements.

I acknowledge that I have read this Appendix A and understand my responsibilities. I understand and accept the type of activities (specific or general) that I may participate in with my Parents/Legal Guardians consent and as supported by this form.
